Summary


At the end of 2022, the Los Alamos Faith and Science Forum completed its sixth year as an official 501 (c)(3) corporation as well as its 9th season of presenting a summer seminar series. The theme of this year's series was God and Cosmos – On the Journey of Truth, Faith, and Reason. These timely issues were addressed weekly by members of the forum in live presentations held in Kelly Hall at Trinity on the Hill Episcopal Church and an electronic format via Zoom. This was the first summer following the Pandemic, and our normal activities resumed. The Forum's external speaker was Dr. Martinez "Marty" Hewlett, Ph.D., Professor Emeritus, University of Arizona, Department of Molecular and Cellular Biology, and currently Professor at UNM-Taos since 2003. Professor Hewlett presented: Darwinian Evolution: Perspectives from Science, Philosophy, and Theology." Our summer lecture series was quite successful, as summarized in this report. The new website

Summer 2022 Activities

Now in its 9th year, the Los Alamos Faith and Science Forum investigates contemporary issues at the interface of faith and science with a weekly lecture series every summer. This year we considered a wide range of topics, under a unifying theme: "God and Cosmos – On the Journey of Truth, Faith, and Reason." We happily reinstated our usual supper-lecture-discussion format at Trinity on the Hill Episcopal Church. In addition, we continued to use social media, via Zoom to stream our talks out to participants who could not attend in person as well as to new participants interested in these topics. The use of zoom's interactive features 'chat' and 'voice' enabled zoom attendees to participate in the question and answer segment and the table discussion. Typically, we had an average of 51.1 attendees of which 36.5 people were live in Kelly Hall and an average of 17.9 people on-line during these talks and the discussions that followed. God and Cosmos: On the Journey of Truth, Faith, and Reason

The Los Alamos Faith and Science Forum invites you to a summer of celebration of being together again and continued examination of issues at the interface of faith and science:

- --extending the discussion on human origins and evolution,
- --expanding the boundaries of faith and embedded truth,
- --exploring the nature of God's interaction with humankind.

This, our 9th season of Wednesday events runs from June 1 to August 3. Our season starts with our invited external speaker – Prof. Martinez Hewlett, professor emeritus of cellular biology from U. Arizona. He now lives in Taos and teaches at UNM. He will review and compare models

for human evolution. Later talks this summer on evolution consider experiments on the origin of life by Patrick Berg, MD and the importance of bacteria and viruses in the evolutionary process by Glenn Magelssen, PhD. In addition, we expand the boundaries of faith with presentations related to religion and science to include two talks related to Eastern Orthodox Christianity by Dr. Victoria Erhart (UNM-LA) and Father Jesse Robinson (Holy Trinity Orthodox Church, Santa Fe). There also will be a talk on the science of Buddhism by John Ambrosiano, PhD, and a discussion on the image of God by Eric Ferm, PhD. The deep issues of truth in faith and God's role in the discovery process will be addressed in talks by Gary Stradling, PhD., Nelson Hoffman, PhD and Chick Keller, PhD.

We are returning to our pre-pandemic mode of an evening program that starts at 6 pm with a light supper, then the featured presentation at 6:30, followed by questions for the speaker, and concluding with table discussions related to the evening's topic.

These events are free and open to the public. They will all be held in Kelly Hall at Trinity on the Hill Episcopal Church, 3900 Trinity Drive, Los Alamos. The hall is large enough for people to spread out as comfortably as they like. The presentations and subsequent discussions will also be available on zoom. Dan Winske, Morrie Pongratz, Susan Sprake and Chick Keller (member) attended the New Mexico Chapter luncheon of the Society of Catholic Scientists held at Fuller Lodge in Los Alamos, NM on October 29, 2022. Nels Hoffman, Susan Sprake, and Glenn Magelssen listened via zoom to some of the Biologos conference this summer. The New Mexico Chapter of the Society of Catholic Scientists NM had a book group study of Christopher Baglow,'s book *Faith, Science, & Reason, Theology on the Cutting Edge*, 2nd Edition and met via zoom. Robert Reinovsky, Dan Winske, and Gary Stradling attended Goshen Religion and Science Conference March 11-13, 2022 online, "Trauma and the Environment: Then How Shall We Live", with speakers, Drs. Ann Milliken Pederson and Jennifer Gubbels, Augustana University. Morrie Pongratz, and Dan Winske attended the Society of Catholic Scientists, SCS Annual National Conference, online June 3-5, 2022. There was no Lenten Series this year and our writer's group did not meet.

2022 Annual Meeting

Summary

The Forum's annual meeting was held in person and via Zoom on Sunday, November 13, 2022. Nineteen Forum members were in attendance along with five non-members. President Susan Sprake presented a summary of the year's activities. Treasurer Bob Dryja presented a financial summary. Glenn Magelssen gave a short presentation on "A Brief History of Wine." A discussion of possible topics for next summer's lecture series occurred. The election of new Board Members took place, as summarized below. Election of Board Members

- Board members of the Forum are elected to two-year terms by vote of attending members.
- Board members serve two-year terms with a maximum of three consecutive two-year terms (6 consecutive years). They must wait one full year before running again.
- Today, elections for board members to serve for 2023 will be held.
- At the board meeting in January 2023, the new Board of Directors will elect <u>new officers</u> for the 2023 year.
- Nels Hoffman, Glenn Magelssen, Morrie Pongratz, and Dan Winske are completing the 2nd year of their 3rd term on the board and are not eligible for reelection to serve in 2023.
- Robert Dryja, Susan Sprake, and Gary Stradling are finishing their 1st year of their 2nd term at the end of 2022. They will begin their 2nd year of their 2nd term in 2023 (no vote necessary)
- Five board members are completing the first year of their 1st two-year term in 2022 and beginning their 2nd year of their two-year term in 2023: Patrick Berg, Andrea Favalli, Nick Hengartner, Daniel Holladay, and John Singleton. (No vote necessary)
- Three board members, Amy Birnbaum, Eric Ferm, and Michelle Stump will finish the 2nd year of their 1st term at the end of 2022. They are up for election to begin their 1st year of their second term in 2023. Michelle Stump has indicated that she wishes not to be considered for a 2nd term. (vote)

Los Alamos Faith and Science Forum 2022 Annual Financial Summary Complete Twelve Months

The following table is for the complete twelve months of 2022. Several members made membership payments or donations during the last week of December.

The Forum nearly maintained the same cash balance for the year. It started with a balance of \$9,125.42 and finished the year with a balance of \$9,119.68. This was a decrease of \$5.74 for the year.

Key Points

- Most financial activity occurred in June through August as a part of the summer program activities.
- Two churches, Bethlehem Evangelical Lutheran Church and White Rock Presbyterian Church, donated \$1,300.00.
- Individual contributions were for memberships or for dinner donations during summer presentations.
- Total income for the year was \$3,287.75 and expenses were \$3,293.49
- Twenty-three people made membership payments for 2023. Nine of these people also made donations or membership payments for 2022 or 2024.
